Benefits Advocacy

DAV service officers provide no-cost counseling on veterans benefits administered by the Department of Veterans Affairs (VA), including disability, health care, pension, survivors' benefits, employment rights, education and more. DAV also provides disaster relief to disabled veterans affected by catastrophes such as tornadoes, hurricanes or floods. DAV service offices can be contacted through **benefitsquestions.org**.

Legislative advocacy

As a nonpartisan organization, DAV seeks responsible legislation to improve benefits and services for disabled veterans, their families and survivors. DAV's legislative goals are set by the organization's members and focus on issues such as disability compensation, medical care, women veterans, employment and rehabilitation programs, as well as burial and survivors' benefits.
